SANITATION SERVICES FOR ENTIRE TOWNS COUNTY SCHOOL COMPLEX FOR GARBAGE PICK UP, SERVICE TO COVER FROM AUGUST 1, 2018 TO JULY 31, 2019.

SUCCESSFUL BIDDER MUST BE ABLE TO PROVIDE TWO TRUCKS EQUIPPED FOR DUMPING AND HANDLING DUMPSTERS USED BY THE SANITATION COMPANY.

SUCCESSFUL BIDDER MUST PROVIDE PROOF OF \$1 MILLION DOLLAR LIABILITY INSURANCE COVERAGE AT THE TIME THE BID IS SUBMITTED.

**\*\* Services need to include:**

- 5 dumpsters (size: 6 yard containers) 3 of which are located behind the school cafeteria and should be serviced five days a week, Monday—Friday, and 2 which are located by the big gym and should also be serviced five days a week, Monday—Friday.
- 1 dumpster (size: 6 yard container) located at the athletic fields, to be serviced 1 time per week on Monday's during the fall months, and twice a month during the winter and spring.
- 1 dumpster (size: 6 yard container) located at the Bus Garage, to be serviced twice a month.

**\*\* Pick Up Service: MUST be completed before 7:00am each morning.**

The period from June 17, 2019 until July 31, 2019 services will change to one time per week at all locations.

**The Bid will cover one year of service beginning August 1, 2018 to July 31, 2019. Bid should specify yearly and monthly total.**

**All invoices are to be sent monthly.**

**Sealed bids** must be received in the Towns County Board of Education's Office at 67 Lakeview Circle, Suite C, Hiawassee, GA 30546 by **Monday, July 2, 2018 at 1:00 p.m.** Bids will be opened at that time. The bid will be awarded at the Board of Education Work Session meeting on Monday, July 2, 2018 and all bidders will be notified the next day. Sealed bids should be marked "**SANITATION SERVICE BID**" on the outside of the envelope. The Board of Education reserves the right to reject any or all bids. It also reserves the right to cancel the agreement with the successful bidder at any time it seems necessary.
