Towns County School Nutrition Charge Procedure

Thanks to the Community Eligibility Provision (CEP) all students enrolled full time at any of the Towns County Schools this school year will be receiving free breakfast and lunch for the entire school year. Parents are not required to complete meal applications in order to receive free or reduced price meals for their children.

Although meals will be free for all students this school year all outstanding charges from previous school years will still need to be paid as soon as possible. If your child had an outstanding balance when school ended in May those charges will still be on their meal account in August.

In order to receive these benefits the student is required to take the entire reimbursable meal at both breakfast and lunch. Students may purchase extra items but will be required to pay for the items that they receive. Prices for extra items range from .75 up to 2.00. Students will need to pay cash or have money already on their meal accounts in order to purchase extra items. No charging for any extra items will be allowed. Parent may still access lingconnect.com and add money to their child's account in order to purchase extra items.

Employees of Towns County School System are allowed to charge meals and extra items to their lunchroom accounts. The charge limit for full time employees is \$75.00. Substitute employees are not allowed to charge meals. Charges need to be paid at the end of each month. If charges are not paid in full by the end of the school year the total amount owed will be deducted from the employee's June paycheck.
